January 7, 2019 Upper Salford, Pennsylvania

Chairman Poatsy shared a **public announcement**:

- The Pennsylvania State Police shared information of a "White Van Scam" where highend home theater goods are sold, at a significantly discounted cost, out of the back of an SUV or van, but are of poor quality.
- Mr. O'Donnell shared that the construction of the bridges on Route 63 will begin with tree trimming that is expected to occur over the next 3 weeks. Delays are anticipated.

**On a motion** made by Mr. Sacks and seconded by Mr. Poatsy, the Board unanimously appointed Kevin O'Donnell as the Emergency Management Coordinator and Robert Hickson as the Assistant Coordinator for Upper Salford Township.

**On a motion** made by Mr. Poatsy and seconded by Mr. Sacks, the Board unanimously adopted the 2019 billing rates for Natural Lands Trust Staff Consultants at the 2018 rate schedule.

A representative was **not appointed** to the Township's Open Space Consultant.

**On a motion** made by Mr. Sacks and seconded by Mr. O'Donnell, the Board unanimously set the rates for seasonal employees performing snow plowing at \$19.00 an hour with time and a half to be paid for work other than normal hours of 7 a.m. to 5 p.m.

**On a motion** made by Mr. Sacks and seconded by Mr. O'Donnell, the starting wage for summer/seasonal help will remain at \$10.00 an hour but will be increased to \$11.50 for those who have worked a year or more.

**On a motion** by Mr. Sacks and seconded by Mr. O'Donnell, the current employee benefits established in the Employee Handbook adopted March 13, 2012, amended on November 10, 2015 and January 3, 2017, stand as adopted.

**On a motion** made by Mr. Sacks and seconded by Mr. O'Donnell, the Board established the standard IRS rates for mileage reimbursement (58 cents per mile effective 1/1/19) for employees that are authorized to use their personal vehicle for Township business.

**On a motion** made by Mr. Sacks and seconded by Mr. Poatsy, the Board of Supervisors approved **Resolution #2019-1** revising the **Fee Schedule** to update the Park Pavilion Reservation fees.

**On a motion** made by Mr. Poatsy and seconded by Mr. Sacks, the Board of Supervisors unanimously adopted **Resolution #2019-2** thereby approving the application of **Morral Tract Minor Subdivision** for the **Final Plan** of a two (2) lot subdivision on a tract of land consisting of 52.38 acres, more or less, located at **1239 Salford Street** and imposing conditions on that approval.

**On a motion** made by Mr. Poatsy and seconded by Mr. Sacks, the Board of Supervisors unanimously approved the bills for the month of January in the amount of \$99,108.96 for payment.

The receipts for the month of January totaled \$56,718.22.

The Treasurer's report as of January 7, 2019 noted the following amounts: total assets, \$8,022,938.27; total liabilities, \$784,712.76; total equity, \$7,238,225.51. Total liabilities and equity equal \$8,022,938.27.

**On a motion** made by Mr. Poatsy and seconded by Mr. O'Donnell, the Board of Supervisors unanimously approved the amended minutes of the November 13, 2018 Board of Supervisors meeting.

**On a motion** made by Mr. Sacks and seconded by Mr. Poatsy, the Board of Supervisors unanimously approved the minutes of the December 11, 2018 Board of Supervisors meeting.

- Mr. Poatsy publicly thanked the road crew for their assistance at the Christmas Tree Lighting.
- Barb Gormley, Wolford Road, inquired about the residents that attended last month's meeting, who had concerns about the spraying at Orchard Park.
