

September 8, 2020  
Upper Salford, Pennsylvania

The September meeting of the Upper Salford Board of Supervisors was brought to order by Chairman Poatsy at 7:30 p.m. Messrs. O'Donnell and Sacks were present, as well as the Township Solicitor, Stephen P. Imms, Jr.

The Board shared several **public announcements**:

- The Board of Supervisors has been meeting with representatives from the EPA and Schwenksville Water Authority to discuss Baghurst remediation efforts.
- The 2020 Census, which began on April 1<sup>st</sup>, is currently taking place. Please continue to complete the Census.
- The Perkiomen Valley Library has opened for curbside pick-up only due to COVID-19. More information can be found on their website. Construction has been completed.
- The Perkiomen Watershed Conservancy Annual Stream Clean-Up has been rescheduled for October 31<sup>st</sup> beginning at Rahmer Park.
- The new Township website is now live.
- The Pull-In Movie on the Mountain, Secret Life of Pets 2, will be held on Saturday, September 12<sup>th</sup>, 2020 and will be limited to the first 100 cars.
- The Folk Fest Earth Day Clean-Up has been rescheduled to Saturday, October 3<sup>rd</sup>.
- Old Goshenhoppen's Oyster Picnic has been cancelled for this year. They are holding their own service and picnic to continue the tradition.

The following reports were presented for the month of August 2020: State Police, Plymouth Community Ambulance Association, Harleysville Area EMS, Zoning Officer, Building Inspector, Park Board, Road Superintendent, and Solicitor.

After the Road Superintendent report:

- *Mr. O'Donnell reported that he met with the Road Master two (2) weeks ago to review maintenance aspects on the roads.*
- *Mr. O'Donnell reported that the tree that fell into a guiderail on Clemmers Mill Road will be removed by a private contractor.*
- *Mr. O'Donnell reported that the State is going to be milling and repaving Perkiomenville Road, between Old Skippack and Old Sumneytown Road.*
- *Mr. O'Donnell reported that they met with the State regarding the traffic light at Barndt Road and Route 63 and there was some deficiency in the signaling as well as a guiderail will be put in around the control box.*

**On a motion** made by Mr. O'Donnell and seconded by Mr. Sacks, the Board of Supervisors unanimously approved the **Purchase Offer** for the **Acquisition of the Right-Of-Way on Rostkowski Road and Sumneytown Pike** in conjunction with County Bridge 296 project to give them access to a slope easement and a temporary construction easement for the purpose of work on the County Bridge.

Mr. O' Donnell reported that the design phase for the **Park to Perkiomen Trail Connector** is nearing completion. Bids for construction will be prepared and advertisement will begin as soon the NPDES permit is obtained. The NPDES permit has been completed and the resubmission has been dropped off to MCCD for their approval.

**On a motion** made by Mr. Sacks and seconded by Mr. O'Donnell, the Board of Supervisors unanimously approved the bills for the month of September in the amount of \$83,293.30 for payment.

The receipts for the month of September totaled \$129,525.01.

The Treasurer's report as of September 8, 2020 noted the following amounts: total assets, \$9,027,117.94; total liabilities, \$766,257.88; total equity, \$8,260,860.06. Total liabilities and equity equal \$9,027,117.94.

**On a motion** made by Mr. O'Donnell and seconded by Mr. Sacks, the Board of Supervisors unanimously approved the minutes of the August 11, 2020 Board of Supervisors meeting, as submitted.
