MONTGOMERY COUNTY, PENNSYLVANIA**

ORDINANCE 2025-1

**AN ORDINANCE AMENDING CHAPTER 1, PART 1. ELECTED OFFICIALS,
A. TOWNSHIP SUPERVISORS, OF THE UPPER SALFORD TOWNSHIP
CODE, REVISING THE COMPENSATION OF SUPERVISORS AND
ESTABLISHING THE PAYMENT BY MONTHLY INSTALLMENTS**

WHEREAS, Act 94 of 2024, adopted by the General Assembly, amended Section 606(a) of the Second Class Township Code, 53 P.S §65606(a), and revised the compensation of supervisors of townships of the second class; and

WHEREAS, Section 606(a) of the Second Class Township Code, 53 P.S §65606(a), as amended, provides that supervisors of townships having a population of not more than 4,999 may be compensated in an amount not to exceed \$3,145.00 per year; and

WHEREAS, the latest available official census figures set the population of Upper Salford Township at 3,172 persons; and

WHEREAS, the Board of Supervisors of Upper Salford Township, determine by adoption of this Ordinance 2025-1, to amend and revise Chapter 1, Part 1. Elected Officials, A. Township Supervisors of the Code of Ordinances of Upper Salford Township to be consistent with Act 94 of 2024.

NOW, THEREFORE, the Board of Supervisors of Upper Salford Township, Montgomery County, Commonwealth of Pennsylvania, hereby enacts and ordains as follows:

**SECTION 1. AMENDMENT OF CHAPTER 1, PART 1. ELECTED OFFICIALS,
A. TOWNSHIP SUPERVISORS.**

A. Section 1-101 of the Upper Salford Township Code is hereby deleted in its entirety and amended to provide as follows:

§1-101. COMPENSATION OF SUPERVISORS

Each Supervisor of Upper Salford Township entering office after the effective date of this ordinance, whether by election or appointment, shall receive compensation as an elected township supervisor in the annual amount of \$3,145.00.

B. Section 1-102 of the Upper Salford Township Code is hereby deleted in its entirety and amended to provide as follows:

§1-102. PAYMENT OF COMPENSATION

Such compensation shall be paid to each eligible Supervisor in 12 equal monthly installments of \$262.08, or in such manner as may otherwise be permitted by law, and approved by Ordinance.

SECTION 2. SEVERABILITY

The provisions of this Ordinance shall be construed as severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance or of the Code of Ordinances. It is hereby declared to be the specific intent of the Board that this Ordinance would have been adopted even if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION 3. REPEALER

This Ordinance shall repeal all ordinances or code provisions of the Upper Salford Township Code of Ordinances which may be inconsistent herewith.


SECTION 4. EFFECTIVE DATE
